Topline Findings



- Americans are worried about the effects of social media.
 - o 71% believe insufficient attention is paid to the dangers of social media.
 - 47% say they would prefer to live in a world where TikTok never existed.
 - 58% believe social media has a negative impact on the lives of children.
- Parents of children ages 5-10 are most likely (41%) to say they prefer to live in a world in which social
 media never existed.
- Gen Z Americans are generally concerned about the effects of social media, though less so than older Americans.
 - o 3 in 5 (60%) say they spend too much time on their phone.
 - o Half (50%) say social media has had a negative effect on young people versus US average of 58%.
 - 1 in 3 (32%) support a total ban of smartphones during the school day.
- There is bipartisan support for greater regulation of social media.
 - 68% of Democrats and 68% of Republicans support banning social media companies from opening accounts for children under 15.
- Americans are less likely than Europeans to want more government regulation of social media.
 - While 42% of Americans believe the government is not doing enough to regulate social media, that proportion is higher in Germany (51%), France (57%) and the UK (65%).



Background

Recent years have seen a growing public concern about the negative effects of social media on society and mental health. In 2016, many left-leaning critics blamed sites such as <u>Facebook</u> and <u>X</u> (formerly Twitter) for enabling disinformation campaigns that skewed the results of the presidential election in favor of Donald Trump. In 2020, similar accusations were made by conservatives, who argued that <u>X</u> and <u>Facebook</u> suppressed information that was unfavorable to Joe Biden.

Meanwhile, scholars have noted an <u>increase</u> in both the average number of daily users of social media over the past decade—from 970 million users in 2010 to 4.95 billion users in October 2023—and the <u>average daily time</u> spent on such sites went from 90 minutes per day in 2012 to 151 minutes per day in 2023. These trends, when coupled with a troubling increase in <u>mental health issues</u>—particularly among teenagers—has led some to call for increased regulation of such sites for our nation's young people.

In this report, More in Common explores people's attitudes towards social media today. We conducted an international comparative investigation of attitudes towards social media use in four countries: the US, UK, France, and Germany. We asked respondents various questions about the societal effects of social media, their attitudes towards government regulation, and their own personal experiences using social media.



Methods

More in Common conducted online survey interviews from April 29th to May 2nd, 2024. The total sample was 8,071 adults, with N=2,014 US adult citizens in the United States, 2,008 in the UK, 2,047 in France, and 2,002 in Germany. The data was weighted to be representative of each countries' citizens using propensity scores, with score functions including gender, age, race, education, and region. The weights for the sample were then post-stratified on 2020 Presidential vote choice, with a four-way stratification of gender, age (6- category), race (5-category), and education (4-category). The margin of error (adjusted for weighting) is +/- 2.2 for the US average and is higher for subgroups.

Note: Numbers in data visualizations are rounded to the nearest whole number. Figures may total to larger or smaller than one-hundred percent due to rounding. Unless otherwise noted, all figures indicate %.








Older Americans are more likely to say that they'd prefer to live in a world where TikTok was never invented.

Which of the following comes closest to your view?



Do you think social media has a positive or a negative impact on the lives of children aged under 15 overall?






American parents of children age 5-10 most likely to say the world would be better if social media were never invented

 I believe the world is better off because social media exists








Majority of Americans believe social media is negatively impacting young people

Do you think social media has a positive or a negative impact on the lives of children aged under 15 overall?







Majority of Americans support banning smartphones in schools

To what extent do you support or oppose these policies? [Schools introducing and enforcing a total ban on smartphones during the school day]








Most Democrats and Republicans support banning accounts from those under 15 years old

To what extent do you support or oppose these policies? [Banning social media companies from opening accounts for anyone under 15 years old]






Bipartisan support for certain government interventions

Some governments have proposed the following measures. Do you support or oppose these? [total support %]







Americans least likely to think government is not doing enough to regulate social media

Conclusions

Overall, these data paint a nuanced picture of how Americans are feeling about the effects of social media on their lives, both across demographics and in comparison to other countries.

While Americans are more sanguine about the effects of social media than their European counterparts, many remain wary of the possible negative consequences of these platforms in their daily lives. This includes Democrats and Republicans, and even our nation's young people, who demonstrate remarkably high levels of skepticism about the effects of social media—though less than older Americans.

Overall, these observations show increasing public concern regarding the potential risks of these platforms.






Thinking about a normal day, how long do you usually go without looking at your phone?








Most Americans think we don't pay enough attention to the dangers of social media






Older generations think increased social media regulation is needed

What is your view of the regulation of social media platforms, like Facebook, TikTok and YouTube? Is the government...








Young people are significantly more likely to be in favor of a world with social media

 I believe the world is better off because social media exists






Most Americans are undecided about whether the US government should force the sale of TikTok

To what extent do you support or oppose these policies? [Forcing the sale of TikTok to an American company]







Do you think social media is a good or a bad thing for society overall?








About half of Americans would prefer to live in a world where TikTok never existed

 I believe the world is better off because TikTok exists






Americans generally undecided about whether the world is better because social media exists







Similar levels of support for government regulation of social media platforms across political affiliations

What is your view of the regulation of social media platforms, like Facebook, TikTok and YouTube? Is the government...







4 in 10 Americans support banning smartphone sales to those under 15


To what extent do you support or oppose these policies? [Banning the sale of smartphones for children under the age of 15]

Do you think social media has a positive or a negative impact on the lives of children aged under 15 overall?






Many parents struggle to limit the amount of time their children spend on their phones

- I find it easy to limit the amount of time my child(ren) spend on their phones








Thinking about a normal day, how long do you usually go without looking at your phone?







Do you think social media has a positive or a negative impact on the lives of children aged under 15 overall?






Around three-quarters of people in all four countries think not enough attention is paid to the dangers of social media








Americans least likely to think government is not doing enough to regulate social media

What is your view of the regulation of social media platforms, like Facebook, TikTok and YouTube? Is the government...








Majority of people in all countries support banning social media for children under 15
